# Relationships Education, Relationships and Sex Education (RSE) and Health Education Curriculum

This new curriculum will be mandatory in all schools by September 2020 and will be part of the Ofsted inspection from this date. Prior to this date, Ofsted will be looking at how schools are planning implementation. The government has made it clear that schools who are ready to deliver high-quality provision from September 2019 should do so. The curriculum will help equip pupils with the appropriate knowledge, skills and tools they need to stay safe, make informed choices and lead happy, healthy lives in both the online and off line worlds. Staying safe online and the responsible use of technology will be taught across all phases, covering areas such as how to keep personal information private, recognising when an online relationship becomes negative and the importance of balancing on and off line activity. The way in which information and data is generated, collected, shared and used online will be also be taught. Issues such as cyber bullying, sexting and accessing harmful content will be addressed in an age appropriate way.

### **Education for a Connected World**

The UK Council for Child Internet Safety (UKCCIS) has developed a new framework, 'Education for a Connected World'. This framework describes, in a developmental way, the knowledge and skills that children and young people should have in order to help them navigate the online world in a positive way. This is an excellent tool to help develop an effective and developmental curriculum from early years through to Key Stage 4. It gives guidance on eight different aspects of online education:

- self-image and identity
- online relationships
- online reputation
- online bullying

- managing online information
- health, wellbeing and lifestyle
- privacy and security
- copyright and ownership


The framework also includes a very useful list of supporting resources, literature and research.

## **Building self-esteem and online resilience**

Live streaming offers the opportunity for children to perform live online and view real time video content. With this technology, however, comes the risk that children may see inappropriate content and may upload too much personal information and thereby increase their vulnerability to exploitation.

Think U Know have created age appropriate activities to help children consider potential risk associated with livestreaming. The activities for eight to 11 year olds are intended to help build self-esteem, confidence and resilience online and offline. The activities encourage children to think about compliments and flattery they may receive online and identify people they can trust.

For young people over 13, the resource Charlie's Story focuses on a case study detailing the sexual abuse of a young person via live streaming and can help explore the concepts of coercion/pressure online, barriers to disclosing and gives advice on where young people can seek support.
