### **Have your Say: Young people's perspectives about their online rights and responsibilities**

This research involved over 24,000 primary and secondary aged children from across the UK. The report was aimed at listening to the voice of children and young people and offers an insight into the experiences they have online. ### **What bothers children online?**

This latest report from EU Kids Online involved nearly 10,000 children from across the EU. They were asked what upsets them and their friends online. Their responses were varied and their mention of risks rose markedly from nine to 12 years old. Younger children are more concerned about content than risks. ### **Apps**

We have all read about children running up huge bills on iPad and iPhone game apps and many other apps. App is short for 'application' and is a small piece of software that performs a specific function. Apps are becoming very popular with children, can be downloaded quickly and are often free, sometimes just in the first instance. Some apps have content that is not suitable for children, so it is always worth reading the T & C and checking the age rating before downloading. ### **Ofsted and eSafety**

The Inspectors Guidance, updated termly, gives clear recommendations and expectations for all schools. Some questions to consider:

- Who are the key eSafety members of staff in your school?
- How is eSafety embedded across the school?
- How are the children and young people involved with promoting eSafety, shaping policies and developing eSafety class rules?
- Who is responsible for the management of personal data and are all staff aware that this falls under the Data Protection Act 1998?

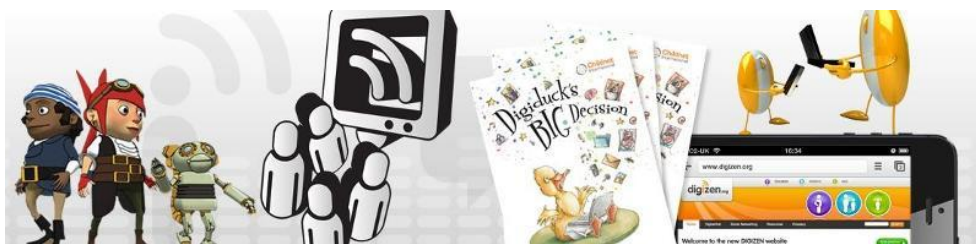
